



ASSIGNMENT OF ROAD HOME GRANT PROCEEDS (Page 1 of 2)

BE IT KNOWN that on this ____ day of _____, 200__ (“**Effective Date**”), before me the undersigned Notaries Public, duly commissioned and qualified, and in the presence of the undersigned competent witnesses, personally came and appeared and declared as follows:

RECITALS

A. The following terms are used in this document:

Road Home Program (Program) is the financial assistance program of the Louisiana Office of Community Development to provide financial benefits to eligible homeowners in the state whose homes were damaged in 2005 by hurricanes Katrina and/or Rita.

Assignment will be known as the act of transferring financial benefits of the Program from an original eligible homeowner to a new homeowner upon legal transfer of property as recognized by the State of Louisiana.

Assignor is the original, eligible homeowner in the Program

Assignee is the purchaser of a home from the original, eligible homeowner in the Program (Assignor).

B. [Assignor](#) entered, or plans to enter, into an application for benefits under the Program with respect to the property more particularly described as [*describe property*] and also described, or to be described, in the Program application

C. Pursuant to and subject to the terms and conditions of the Program, Assignor has agreed to sell to [Assignee](#) and [Assignee](#) has agreed to [purchase](#) from Assignor any interest Assignor may have in the financial benefits that he/she may or may not obtain from the Program regarding subject Property.

D. The Program provides that interest in the financial benefits, if any are due the Assignor under the Program policies, may be [assigned](#) by [Assignor](#) to [Assignee](#).

E. [Assignor](#) desires to [assign](#) Assignor's interest in the financial benefits of the Program to Assignee and Assignee desires to accept the [assignment](#) from [Assignor](#). NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in consideration of the mutual covenants contained herein, [Assignor](#) and [Assignee](#) agree as follows:

1. [Assignor](#) does hereby [assign](#), transfer, convey, set over, and deliver the [Agreement](#), and all of [Assignor's](#) right, title and [interest](#) therein, unto [Assignee](#) including, without limitation, [Assignor's](#) right, title and [interest](#) in any Program financial benefit that may or may not be provided regarding subject property

2. Assignee accepts the [assignment](#) of the [Agreement](#) from [Assignor](#), and [Assignee](#) assumes, and binds itself to perform and discharge all of the obligations to be performed or discharged by [Assignor](#) under the Program and any covenants required to be signed in exchange for receiving benefits under the Program.

3. Assignee and Assignor agree to participate in the Program application process, including, but not limited to, completion of required applications, authorization to verify any and all information provided as part of the application for the purposes of establishing eligibility, provision of ownership, identify, title and mortgage information, and participation in the application and closing proceedings as required by the Program to process benefits.
